4. The overall migration limits, together with the specific restrictions to which the articles may be subjected, showed the articles to be suitable for food contact.

The specific migration tests (CAS 106-99-0, CAS 36443-68-2, CAS 110553-27-0, CAS 2082-79-3, CAS 38613-77-3 and zinc salt) carried out in the transfer liquids acetic acid 3%, ethanol 50% and vegetable oil at the accredited laboratory gave favourable results, showing full compliance with the limits set by current legislation.

Substances regulated by EC Regulations No. 1333/2008 and EC Regulations No. 1334/2008 (substances called "dual use") are present in the material: Titanium Dioxide CAS 0013463-67-7 and Polydimethylsiloxane CAS No. 63148-62-9)

5. This declaration is made in accordance with Article 16 of the European Community Framework Regulation 1935/2004 EC.

6. The industrial or commercial use of the material indicated in this declaration is subject to verification of its compliance with the applicable standards as well as its technological suitability for the intended purpose.
